Note:

- Dangerous goods of the second Category 2 on import/export, subject to escort of the port security services may stay in port for 5 working days either in the container terminal or any other site authorized, under the responsibility of the stevedore.
- Handling of category 1 dangerous goods in transit by the stevedore is prohibited except on special authorization from the port authority at the request of the shipping agent/company and under the responsibility of the stevedore.

Note:

- 1. UN Numbers (United Nations) and class must be attached as hazardous stickers on all four sides of the containers
- 2. Category 3 dangerous goods on import/export can stay in port for 10 working days either in the container terminal or any other authorized site, under the responsibility of the stevedore.
- 3. Consolidated Cargo:
 - a. Groupage containers are not authorized to contain hazardous materials of the first category 1
 - b. Groupage containers belonging to one or more importers are authorized to contain category 2 and category 3 Dangerous goods, in condition that the unstuffing takes place in a port authorized area for general goods under the responsibility of the stevedore and HSE services. After Unstufing the dangerous goods of category 2 must leave the port under the port security services' s escort.
- 4. Dangerous goods in transit on board ships is authorized for all categories in condition that they are stored on board in a totally safe and secured position under the responsibility of the master of the ship.
- 5. Handling of dangerous goods of category 2 and 3 in transit by the stevedore is authorized at the request of the shipping agent/company and under the responsibility of the Stevedore.
- 6. Transshipment of first Category 1 dangerous goods are authorized under condition that full operation is done simultaneously while both ships (Mother vessel and Second Vessel) are at berth. Operation must be carried out under the responsibility of the stevedore and both masters of the concerned ships.
- 7. Storage at terminal of categories 2 and 3 dangerous goods in transshipment is authorized up to 15 working days under the responsibility of the stevedore on shipping company's request.

- 8. Dangerous goods of Class 7 on import, export, in transit or transshipment must present all the necessary agreements before discharging, loading, transiting, or transshipping from, to or via Pointe-Noire port.
- 9. All dangerous goods manifests must specify the final destination of the goods, whether import, export, transshipment or transit.
- 10. Shipping compagnies/agents must ensure that all escorts & administrative authorizations costs are been settled before the ship's arrival.
- 11. Any offender is liable to sanctions as per applicable law & effective regulations. The management of Pointe-Noire Port attach highest importance to the strict application of these instructions.
