

#### A. DEMURRAGE

This sub-rule sets out the charge for the use of land assessed on the container for remaining inside the marine terminal after the expiration of the free time until the container is delivered to the lawful receiver of the goods or its representatives (demurrage charges), unless the carrier has agreed to different terms, in writing, which may be more favorable to the merchant, in which case such terms shall apply.

### **A.1 IMPORT CONTAINERS**

The merchant is liable for demurrage charges assessed on the import containers, which will be charged only once to the cargo interest by either the marine terminal operator or the carrier. In the event the carrier charges the merchant, the demurrage charges will be calculated as set forth below. In the event the marine terminal operator charges the merchant, the demurrage charges will be calculated as set forth below or as set forth in the marine terminal operator's public tariff. Currency: USD

#### C. DETENTION

This sub-rule sets out the charge assessed for the use of the carrier's container while the container remaining inside the marine terminal or railroad facilities or container yard or while the container is undergoing U.S customs examination, or while the container undergoing reworking of cargo inside the container for safety reasons, after the expiration of free time until the container has been delivered to the lawful receiver of the goods or its representatives (detention charges), unless the carrier has agreed to different terms, in writing, which may be more favorable to the merchant, in which case such terms shall apply.

### **C.1 IMPORT CONTAINERS**

The merchant is liable for the detention charges assessed on import containers, which will be charged as set forth below either by the marine terminal operator or by the Carrier.

### D. PER DIEM

This sub-rule sets out the charges assessed by the carrier, after the expiration of the free time, for the use of the Carrier's container (full or empty) outside of the marine terminal, rail road or container yard facilities until it is returned to the carrier's custody at the carriers designated place of return (per diem charges), unless the carrier has agreed to different terms, in writing, which may be more favorable to the merchant, in which case such terms shall apply. The per diem charges are for the merchant account, except that the carrier will invoice merchant truckers providing they are holders of a legitimate executed interchange agreement with the carrier. The merchant remains liable for the charges up to the return of the container into carrier's custody at the carriers designated place of return, until the charges have been paid by the trucker, regardless of whether the relevant trucker has executed an interchange agreement.

## **F.** Special conditions unless otherwise provided in this rule:

Where the carrier has agreed to a free time (extended free time) that is longer than the applicable standard free time set out in this rule (standard free time) without specifying the applicable demurrage charges and/or storage charges and/or detention charges and/or combined detention charges (as applicable) after the extended free time, the merchant shall start paying the charge as set out in this rule for each day after the extended free time has expired, until the day the container has been delivered to the lawful receiver of the goods or its representative(s) and/or returned to the carrier's custody at the carrier's designated place of return(as applicable). The extra free days granted with the extended free time in comparison (extra free days) shall count as chargeable days for the calculation of the charges, except that no charge will be assessed on the said extra free days.
