


MyMSC Instant Quote

- To retrieve a quotation using Instant Quote, navigate to either the Instant Quote button found in the top right of the dashboard, or use the drop-down menu located in the top left of the dashboard



- Start by designating the equipment type. Instant Quote supports dry 20DV, 40DV, 40HC as well as 20RE and 40HR reefer container types

Note: For special equipment types, hazardous, Shipper Owned containers or quotations with extended cargo protection please select the Tariff Form also found within the dashboard drop-down menu

Equipment Type

The form contains two dropdown menus. The first is labeled 'Select equipment type' and has 'Dry' selected. The second is labeled 'Select Equipment Size' and has three checked options: '20DV', '40DV', and '40HC'.

- Next, select between Freight All Kinds (FAK) or commodity specific. If choosing commodity specific, you may type either the harmonized code or a short description and choose from the options that populate


