9	Outbound - Late Shipping Instruction Fee	IDR 600,000	Export	This fee is applied when customer submitted the Shipping Instruction (SI) later than the MSC published FINAL SI Cut off (i.e., 2 x 24 hours before vessel ATD)

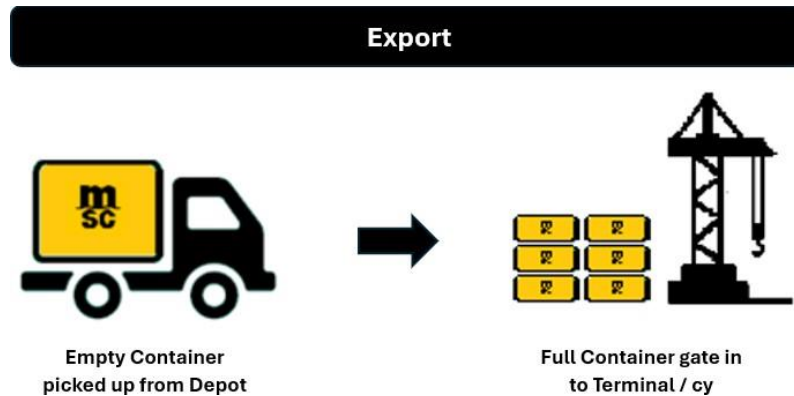

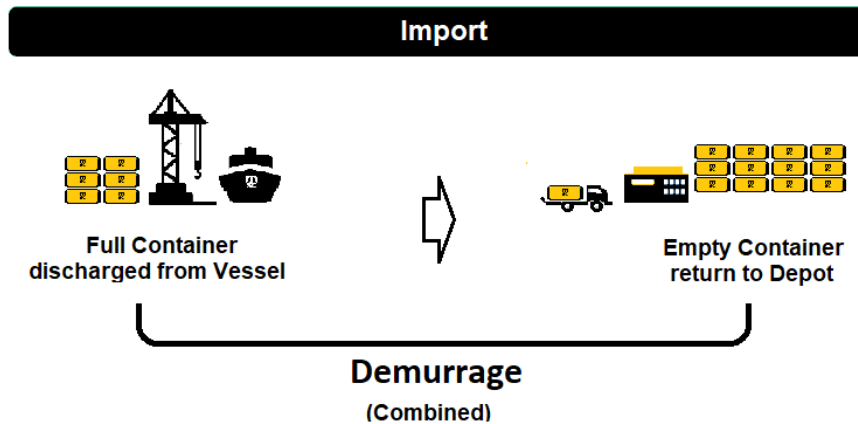
