We as MSC Gemi Acenteliği A.Ş, care for the security of your personal data processed by us as data controller defined under Personal Data Protection Law no.6698. Consequently, we would like to inform you on the processing of your personal data.

PURPOSE AND LEGAL REASON FOR PROCESSING OF YOUR PERSONAL DATA

Your personal data is being processed for the purposes and legal reasons stated below, in accordance with the Personal Data Protection Law no. 6698 and secondary regulations stated thereunder:

In this context, your personal data so provided, such as **“Name, Surname, E-mail, Phone Number,”** are being processed on the basis of legal reason of execution of the agreement, in accordance with article 5/2-c of the Law no. 6698, for the purpose of conveying pre-agreement price offers and executing agreement with the most affordable offer.

TRANSFER OF PERSONAL DATA

MSC Gemi Acenteliği A.Ş may share your personal data for the purpose of assessing price offers and providing information on offers, to its partners and affiliates (and/or third party business partners who need to be shared for the execution of the business) in accordance with articles 8 and 9 of the Law.

PERSONAL DATA COLLECTION METHODS

MSC Gemi Acenteliği A.Ş collects your personal data via the form you have completed on MSC website. In addition, your personal data may be collected by other methods whereby you contact MSC Gemi Acenteliği A.Ş.

STORAGE OF PERSONAL DATA

Your personal data shall be stored for a limited period of time, for the performance of the contractual relationship, and the expired documents shall be destroyed as a result of period reviews in accordance with article 5(2)(c) of the Personal Data Protection Law no. 6698.

YOUR RIGHTS RELATED TO YOUR PERSONAL DATA

As the data subject, you have the right to apply to MSC Gemi Acenteliği A.Ş and;

- to learn whether your personal data is processed,
- to request information if your personal data is processed,
- to learn the purpose of processing of your personal data and whether this data is used for intended purposes,
- to know the third parties to whom your personal data is transferred at home or abroad,

- to request the rectification of the incomplete or inaccurate personal data, if any, and to request notification of the transactions made within this scope to third parties to whom your personal data is transferred,
- to request the erasure or destruction of your personal data upon cessation of reasons for processing, and to request notification of the transactions made within this scope to third parties to whom your personal data is transferred,
- to object to the processing, exclusively by automated systems, of your personal data, which leads to an unfavourable consequence for you,
- to request the erasure or destruction of your personal data under the conditions stated in article 7 of the Law, and to request notification of the transactions made, to the third parties to whom your personal data is transferred,
- to request compensation for the damage arising from the unlawful processing of your personal data.

If you convey your requests related to your rights listed above, to MSC Gemi Acenteliği A.Ş in accordance with the application procedures stated in the Communique on the Principles and Procedures of Application to the Data Controller, MSC Gemi Acenteliği A.Ş. will conclude your request free of charge, and as soon as possible, and in any case within maximum 30 (thirty) days, depending on the nature of your request. However, MSC Gemi Acenteliği A.Ş. may charge a fee stated in the tariff set by Personal Data Protection Board if the process requires an additional cost.
